- enhancing credibility of reports and claims made about social responsibility

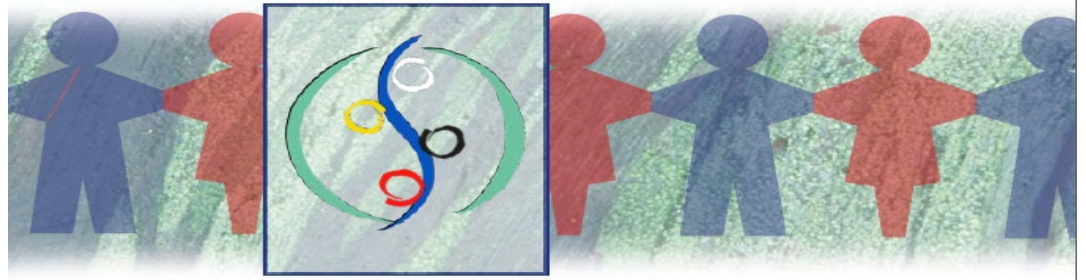

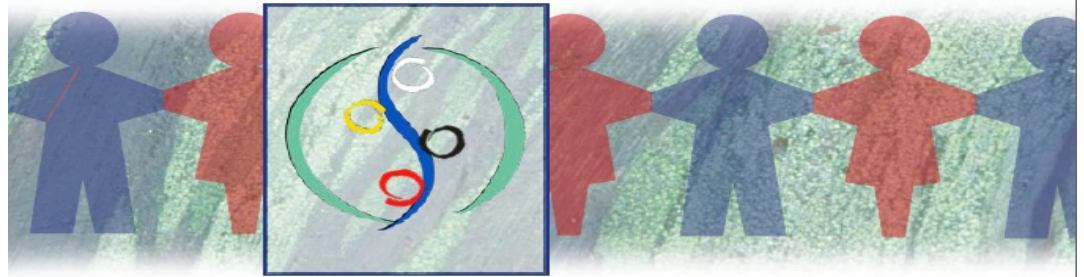

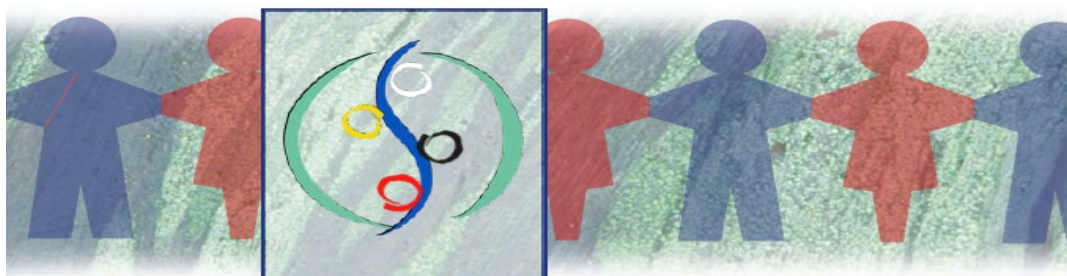
