ACI conducted Energy Audit to Dragon Centre Management Limited and Chevalier Commercial Centre





The electricity consumption in Hong Kong is mainly contributed by buildings in which commercial buildings consume a large portion of electricity. As such, the Government enacted the Building Energy Efficiency Ordinance (BEEO) in order to regulate the energy efficiency of key building services installations inside prescribed buildings.

After implementation of the BEEO, enhancement of the building energy efficiency in Hong Kong is expected. Not only does it save electricity bill, but it also helps reduce greenhouse gas emissions and improve air quality in order to bring about a more pleasant living environment.



The owner of a commercial building or the commercial portion of a composite building (irrespective of newly constructed or existing one), every 10 years, is required to engage a Registered Energy Assessor to carry out



energy audit for 4 key types of central building services installation, namely, air-conditioning installation, electrical installation, lighting installation as well as lift and escalator installation, in accordance with the latest edition of the EAC.

Embracing the ESG Trend: A Pathway to Sustainable and Responsible Business

In recent years, Environmental, Social, and Governance (ESG) considerations have emerged as a crucial factor for businesses worldwide. ACI recently applied our training courses for the Pilot Green and Sustainable Finance Capacity Building Support Scheme, which they are 1) Corporation Level Greenhouse Gas (GHG) Emissions Quantification and Reporting; 2) Corporation Level Greenhouse (GHG) Gas **Emissions** Accounting and Verification: Environmental, Social and Governance (ESG) Introduction.



This scheme aims to support talent development in GSF by providing subsidies to market practitioners as well as prospective practitioners in taking up relevant training and acquiring relevant professional qualifications. The Scheme will run for a pilot period of three years and is administered by the Secretariat of the Centre for Green and Sustainable Finance (Secretariat).

ACI will continue to demonstrate our commitment to sustainable development and aim to make a meaningful and positive impact on the environment, society, and governance practices.

Implementation of the remaining 4 elements of Part 3 of Appendix 4 of the Factories and Industrial Undertakings (Safety Management) Regulations

The Factories and Industrial Undertakings (Safety Management) Regulation made by the Commissioner for Labour was approved by the Legislative Council on 24 November 1999 and came into effect on 1 April 2002. It provides for the introduction of a safety management system in selected industrial undertakings.

To facilitate proprietors and contractors to implement a safety management system applicable to Hong Kong, the Regulation provides for 14 process elements. Initially, contractors or proprietors in relation to construction sites, shipyards, factories and other designated industrial undertakings are required to implement the first 10 of the 14 process elements of the safety management system, and to carry out safety audits of their safety management system.

For the rest of the 4 process elements are not yet implemented, which they are 1) Evaluation of job related hazards or potential hazards and development of safety procedures; 2) Promotion, development and maintenance of safety and health awareness in a workplace; 3) A programme for accident control and elimination of hazards before exposing workers to any adverse work environment; 4) A programme to protect workers from occupational health hazards.

The purpose of the implementation of the regulations is to familiarize relevant industries with the safety management system and prepare for the implementation of the remaining four elements. The labour department have conducted multiple reviews with the industry, and most of the responses from the industry have been positive. There is no objection to the implementation of the remaining 4 elements. So we may foresee the future safety audit would need to be included all 14 process elements.
