ISO 22301 The Business Continuity Management Systems Standard

ISO 22301 is the new international standard for societal security - business continuity management. It specifies requirements to plan, establish, implement, operate, monitor, review, maintain and continually improve a documented management system to protect against, reduce the likelihood of occurrence, prepare for, respond to, and recover from disruptive incidents when they arise.

The standard provides organizations with a framework to ensure that they can continue operating during the most challenging and unexpected circumstances, such as strikes, financial crises, SARS type pandemics, natural disaster or civil disorders, etc. by protecting their staff, preserving their reputation and providing the ability to continue to operate and trade.

ISO 22301 integrates the management of emergency, risk and crisis, using essential tools such as security, continuity and disaster management, crisis communication and control. It can be used by any public and private sectors such as utilities, telecommunication, finance, transport or community enterprise and association regardless of type, size and nature.

- Enhanced capability to handle disruption and protect brand reputation when integrated with business planning.
- Allow easier and swifter recovery from disruptive incidents to minimize losses.
- Preserve markets by ensuring continuity of services in a crisis.




