You should have a good knowledge of ISO 9001:2008 and the key principles of a QMS. If not, we strongly recommend you attend our ISO 9001:2015 Requirements course. It will also help if you have attended an internal auditor course or have experience with conducting internal or supplier audits.

Course Certificate
