- The certification mark shall not be used, unless the statement, “The product is manufactured under an ISO 9001/ ISO 14001/ ISO 50001/ ISO 45001/ IMS management system / Six Sigma certified company, ACI-HACCP & ACI-5S certification” is stated.

部份認證

Partial Certification

標誌不適用於個別附屬公司獲認證的母公司。
The mark cannot be applied to the corporate that only some subsidiaries are certified.



標誌不適用於只有個別旅行團獲認證的旅行社
The mark cannot be applied to the travel agency if only some tours are certified.

Partial Certification

標誌不適用於超過一間公司而其中只有個別公司已獲取認證。

The mark cannot be applied to a group of companies in which only some of them are certified.

Product Label or Packaging

不得將認證標誌使用在最終產品標籤或包裝上。但可以文字形式在產品標籤或包裝上註明“生產該產品的廠房已通過了ACI質量/環境/職健安/能源/綜合管理體系/六西格瑪/國際認可認證有限公司-食品危害分析和關鍵控制管理體系/國際認可認證有限公司-5S的認證”。而註明並不可含有產品認證之意。

The certification mark shall not be used on ultimate product label or packaging. However, a statement of "The product is manufactured under an ACI ISO 9001/ ISO 14001/ ISO 45001/ ISO 50001/ IMS management system/ Six Sigma certified company, ACI-HACCP & ACI-5S certification" may be printed on ultimate product label or packaging. The statement cannot imply product certification.
